A brief discussion was held by the Planning Commission acknowledging Derry Township Municipal Authority's projected plan to expand the waste water treatment plant located next to their existing plant which will be located in Londonderry Township. The expansion is needed in order to increase the capacity for additional use for future development. Department of Environmental Protection Agency requested a planning module by Londonderry Township with acknowledgment of DTMA's expansion. The increased capacity would benefit Londonderry Township's future needs.
