#### **CLEARED FOR PUBLIC DISTRIBUTION**

#### **CURRENT SITUATION**

PADOH continues coordination efforts with FEMA, PEMA, and other state agencies through the Department Operations Center (DOC) to mitigate the impacts of COVID-19. DOH focus remains on Long-term care facility outbreaks and joint agency planning for potential COVID-19 impacts on educational institutions.

Currently, there are 167,928 (+1,376) positive cases and 8,299 (+27) deaths in Pennsylvania. As of 1200 October 8, 2020, there have been positive cases at 999 (+5) LTC/PCH facilities, 43 jails/prisons, and 345 (+5) food industry facilities. 81% of all Pennsylvania positive cases are considered recovered. A recovered case is one that has not been reported as a death and is more than 30 days past the date of the positive test or onset of symptoms.

As of 1530 on October 7, 2020, there were 7,586,904 (+52,928) cases in the U.S, and 36,349,500 (+369,213) worldwide. There have been 212,420 (+928) deaths in the U.S. and 1,058,698 (+6,491) throughout the world.

Epidemiological investigations and contact tracing continue throughout the state to determine potential exposure of additional persons. The PA state lab has increased capacity to account for the testing surge. Commercial and medical system labs are on-line and testing for COVID-19.

Gov. Wolf and Sec. Levine announced 10/6/20 amended sections of the July 15 mitigation orders becoming effective 10/9/20. Amended orders now include a "maximum occupancy calculator" for both indoor and outdoor events. Based on a venue's established occupancy limit as defined by the NFPA Life Safety Code, venues apply appropriate percentage of occupancy to determine how many attendees are permitted to attend an event or gathering.

#### Timeline:

August 6, 2020 – Governor Wolf recommended all Pre-K-12 school and recreational youth sports be postponed until at least January 1, 2021

August 19, 2020 – Contact Tracing Mobile App pilot program begins – app will be available early September August 25, 2020 – Dr. Levine announced Pennsylvania's COVID-19 Mobile Response Unit, CATE (Community-Accessible Testing and Education), to provide testing and education to minority and underserved communities. Governor Wolf also presented his fall legislative agenda for COVID-19 support and recovery.

September 1, 2020 – Governor Wolf signed the second renewal of the COVID-19 Disaster Declaration for State Response and Recovery. All DHS licensed care facilities completed universal testing by the August 31, 2020 deadline. September 3, 2020 – Secretary Levine released updated skilled nursing facility guidance, including updated routine testing strategies

September 8, 2020 – Governor Wolf announced that restaurants can increase indoor occupancy back to 50% starting September 22, 2020 – Governor Wolf and Secretary Levine announced the launch of the COVID Alert PA app, which uses Bluetooth technology to let a person know that they have been exposed to COVID-19 without compromising identity or location. Updated guidance regarding testing and visitation for personal care homes, assisted living residents, and private intermediate care facilities was also released.

September 25, 2020 – Secretary Levine announced the closing of the remaining nine Walmart drive-thru COVID-19 testing sites across the state at close of business due to steadily decreasing registrations. DOH has also contracted with AMI Expeditionary Healthcare to provide pop-up COVID-19 testing sites in Centre and Columbia County.

October 1, 2020 - PADOH no longer coordinates distribution of Remdesivir (Veklury). Healthcare facilities can procure the medication direct from the vendor.
