CURRENT SITUATION

PADOH continues coordination efforts with FEMA, PEMA, and other state agencies through the Department Operations Center (DOC) to mitigate the impacts of COVID-19.

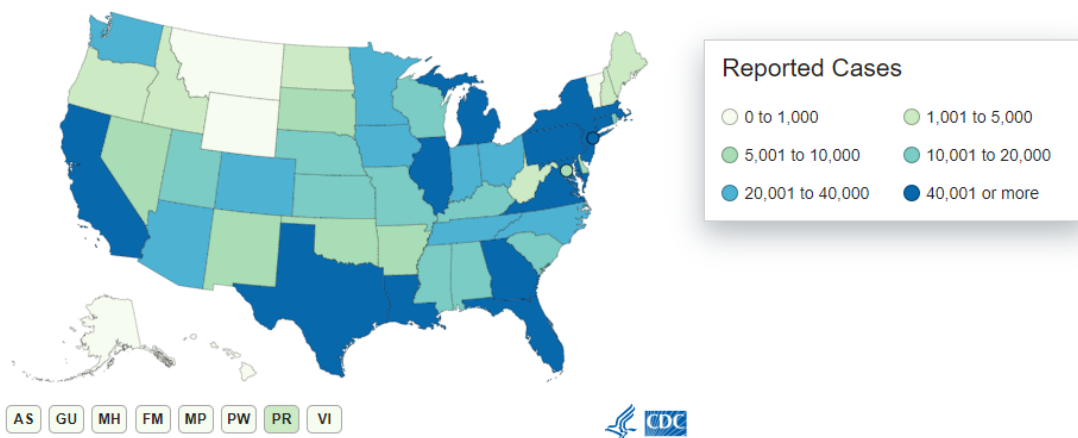
Currently, there are **73,942 (+537)** positive cases and **5,817 (+75)** deaths in Pennsylvania. As of June 4, 2020, there are positive cases at **613** LTC/PCH facilities, 41 jails/prisons, and **213** food industry facilities. **69%** of all Pennsylvania positive cases are now considered recovered. A recovered case is one that has not been reported as a death and is more than 30 days past the date of the positive test or onset of symptoms.

As of 1800 on June 4, 2020, there were **1,867,620 (+20,208)** cases in the U.S, and **6,589,090 (+143,633)** worldwide. There have been **107,979 (+1,283)** deaths in the U.S. and **388,499 (+5,280)** throughout the world.

Epidemiological investigations and contact tracing continue throughout the state to determine potential exposure of additional persons. The PA state lab has increased capacity to account for the testing surge. Commercial and medical system labs are on line and testing for COVID-19.

34 jurisdictions report more than 10,000 cases of COVID-19.

Timeline:

- February 2, 2020 - PADOH Department Operations Center Activation
- March 4, 2020 - PEMA CRCC activation
- March 6, 2020 - Governor's Proclamation of Emergency
- March 11, 2020 - The World Health Organization declared COVID-19 a pandemic
- March 16, 2020 - Governor' School Shutdown Order
- March 19, 2020 - Governor's Order for all non-life sustaining business to close
- March 30, 2020 - FEMA Disaster Declaration (FEMA 4506-DRPA)

- April 1, 2020 - Governor Wolf expanded the stay-at-home order to include the entire commonwealth
- April 3, 2020 - citizens should wear a nonmedical or homemade mask when leaving their homes

April 15, 2020- Secretary Levine signed an order directing protections for critical workers who are employed at businesses that are authorized to maintain in-person operations during the COVID-19 disaster emergency.
 April 22, 2020 - Governor Wolf unveiled his detailed plan for opening the commonwealth with a start of May 8, 2020. This reopening has three phases: red, yellow, and green. Phases are assigned based on conditions in a county, counties, or region. In addition, Secretary Levine outlined DOH’s plans for contact tracing, case investigation, and increased testing capacities as these counties move to ease restrictions.

May 7, 2020 - Governor Wolf extended the stay at home order for counties in the red phase until June 4, 2020
 May 8, 2020 - Phased reopening for Round 1 yellow counties
 May 15, 2020 - Phased reopening for Round 2 yellow counties
 May 22, 2020 - Phased reopening for Round 3 yellow counties and Round 1 of green counties
 May 29, 2020 – Governor Wolf announced phased reopening for Round 4 of yellow counties and Round 2 of green counties

- 16 counties will move from yellow to green on June 5, 2020: Allegheny, Armstrong, Bedford, Blair, Butler, Cambria, Clinton, Fayette, Fulton, Greene, Indiana, Lycoming, Mercer, Somerset, Washington, and Westmoreland
- 10 counties scheduled to enter yellow phase from Red phase on June 5, 2020: Berks, Bucks, Chester, Delaware, Lackawanna, Lancaster, Lehigh, Montgomery, Northampton, Philadelphia

June 3, 2020 – Secretary Levine announced that Walmart and Quest Diagnostics are opening drive-through testing locations throughout the commonwealth in areas with fewer testing sites. There will be a soft opening of five sites beginning on June 5, 2020.

NON COVID-19 Situational Update: Heavy storms rolled through the commonwealth on June 3, 2020 – primarily impacting the southeast. Multiple healthcare facilities in this region were affected and some lost power due to the heavy storms. Some facilities still do not have commercial power.

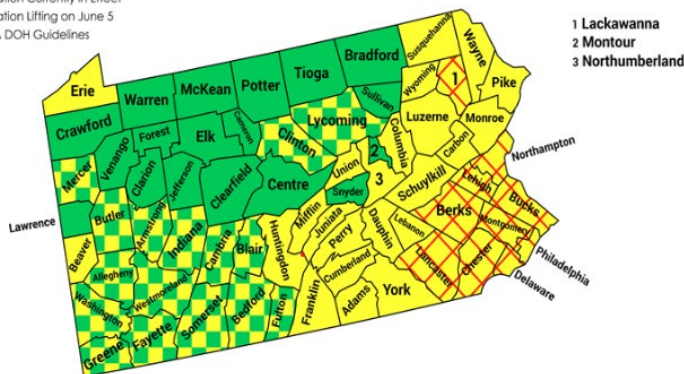
