On Lot Sewage Disposal System Progress District "A" June 1, 2017 – June 30, 2018

The Township's OLSDS (On-Lot Sewage Disposal System) pumping and reporting management program for the District "A", 2017 - 2018 timeframe has been completed. District "A" lies roughly south of Foxianna Road and extends south and west to the Township Boundary and includes all of the islands in the Susquehanna River that lie in Londonderry Township.

The OLSDS District Map is available thru the Township website or at the Township office if needed.

THE OLSDS INSPECTION AND PUMPING PROGRAM HAS BEGUN FROM JUNE 1, 2018 THRU JUNE 30, 2019.

This round of testing will be a repeat for those residents living in District 1 and 2 and will include the same area that was first done during the 2014-2015 timeframe. This also represents the beginning of the 2nd Cycle of the regular 4-year rotation interval required to be done by the DEP for each District in the township.

If your property contains an on-lot sewage disposal system, it must be pumped and inspected at minimum four (4) year cycles as established for your District in accordance with the requirements of this program as set forth by the DEP. Pumping and inspections done at any other time before the designated timeframe for your district cannot be accepted by the Township as compliance with this program. Failure to comply within the reporting time frame requirements of this program will result in fines being levied against the property owner(s) that have not provided the required information.

The citizens of Londonderry Township are to be commended for their participation in completing this required inspection and reporting process. Although there have been a few non-compliant properties in each District, the Township has since achieved almost 100% compliance with this mandatory program to date.

Winter Maintenance and Snow Removal

Like it or not, it will be cold and snowy again soon. The Londonderry Township Public Works Department is ready for the winter season.

We are always looking to recruit part-time snow plow truck drivers, CDL and non-CDL drivers. If you or anyone you know is interested, please fill out an application at the Township office located at 783 S. Geyers Church Road.

When we are not performing winter maintenance on roads, we will be doing other maintenance tasks on various Township roads and other tasks needed to be done. Please be alert for Work Area signs, equipment and Public Works employees.

Following are additional reminders for snow removal:

- Do not place snow on Township roads, in drainage ditches or over storm drains. If you have a storm drain in front of your property, please keep it clear of leaves and all debris.
- If you have a basketball net that hangs over any portion of a Township road, please remove it. It is a
 hazard for passing vehicles, including garbage trucks, delivery trucks and especially snow plows that
 need to get close to the curbing and edge of the road. Residents should take time to be sure to secure
 any loose or broken mailboxes, fences or other property that lies within close proximity to the roadways
 to prevent avoidable damage from normal snow plowing operations.
- When snow falls, please be patient. Our crews salt 67 miles and plow 135 lane miles of Township and State roads. We will do our best to get a plow truck to your street as quickly as possible.
- If you clear your driveway before the street is plowed, pushing or blowing of snow into the streets is not permissible. When the plow truck comes by, the snow will inevitably end up back on your property. It is **NOT** the responsibility of the Township to clear the end of your driveway once the plow has passed through.
- When a snowstorm is forecast, **remove all vehicles** from Township roads so the entire road can be plowed.
- Plowing main arteries will be our first priority, followed by secondary roads and then developments.
- Sidewalks and fire hydrants must be cleared within 24 hours after the end of a snow or ice event.

Tax And Pumper/Hauler Updates

Tax Collector News Loren M. Bowen

It's hard to believe summer is gone. School's back in session and the discount period for taxes is over.

OCCUPATION TAX EXEMPTION – There is an exemption for the \$250 occupation tax if you are a full time student both semesters, if you have less than \$6000 in earned income for the calendar year, if you are over 70 on July 1 of the current year, or if you are full time clergy with no other source of income over \$6000. This exemption is for the occupation tax only. There is no exemption for the \$10 per capita or the \$5 township tax. Also you *must* file an "occupation tax exemption form" with me. Writing notes on the tax bill or sending me college transcripts, etc. does not qualify for an exemption. Exemption forms are available at my office or can be downloaded at www.ldsd. org. Go into taxes and look for the occupation tax exemption form.

3 PAYMENT PLAN – The school real estate tax can be paid with 3 payments instead of all at once. You do lose the 2% discount if you use the payment plan. The first payment would have to be paid by the end of August in order to take advantage of the payment plan. The second payment is due by the end of October and the last payment by the end of November (you only have 30 days to get the last one in!).

You may pay all of your taxes with one check if you wish.

Fall into a Sustainable Practice this Autumn

Compost is done through the natural process of decay that transforms organic waste into a valuable soil amendment. This amendment is nicknamed "black gold" due to its nutrient dense make up that helps strengthen the soil food web and plants.

Organic materials that should be

composted make up roughly 30% of landfill waste. When these materials decompose in landfills they break down anaerobically, which is a longer process that emits harmful methane gases. Composting allows you to reduce your carbon emissions and waste while also providing you a FREE valuable soil amendment.

Composting is a simple and easy activity, that only requires you to monitor four basic things; water, food, air and temperature. To make compost you will need decomposers (don't worry they come to your pile naturally) and food for them to decompose. Their food, the organic materials you put in the composter, should have the correct balance of nitrogen and carbon. By properly maintain your pile, you can speed up the naturally slow decay process to produce fast finished compost.

WATER: your compost bin should feel like a damp sponge. If too dry your decomposers will slow down and if it is too wet the pile will begin to break down anaerobically. If too dry add water and turn the pile, if too wet add browns and turn the pile.

FOOD: all organic materials will compost but not all should be added. Your decomposers will thrive on a balanced diet of carbon and nitrogen materials. Carbon rich organic wastes are known as browns and nitrogen organic wastes are known as greens. The correct balance is hard to define but usually a 2-part green to 1-part brown will give you the best carbon to nitrogen balance.

TEMPERATURE: the preferred temperature for a compost bin is in the range of 90-160°F, with the ideal balance being in the 120-160°F range. A thermometer is a nice tool to monitor the temperature. If it gets too hot or cold the decomposers will die, stopping activity. This component is dependent upon weather; you can compost throughout the winter months but if the



temperature drops below freezing composting will cease until the temperature rises.

AIR: airflow is essential to keep a compost pile going. By doing this no foul odors should be present due to aeration. Aerobic composting offers the fastest results but requires the most maintenance. To ensure airflow

is getting throughout your pile make sure you turn it each week and add browns, they help to create porosity.

Fall is a great time to start a compost bin or pile due to the abundance of organic materials to compost such as; leaves, garden trimmings from end of year plantings, cornstalks and hay. It is also a great time for beginners to start because of the more temperate climate. The abundance of materials allows you to play with the pile to see what ratios work with what ingredients, and the climate ensures your pile will not "cook" as fast, allowing you time to get to know your pile. Starting a fall compost bin allows you to have finished compost come next planting season. So, what better time to start composting than this fall!

When mowing your lawn this Autumn, make sure you keep all grass clippings and garden trimmings off the road.

When left on our roads, they can create dangerous driving conditions, especially for motorcyclists, as well as add to stormwater runoff. This debris, often times containing fertilizer, is not meant to be in our waterways and disrupts the natural ecosystem. Please make sure to either blow your clippings



or sweep them from the road. DO NOT DUMP DOWN THE STORM SEWER. It is also a good idea to leave the clippings on your lawn, they serve as a great natural fertilizer!

HOW TO REPORT A SPILL OR **ILLICIT DISCHARGE IN YOUR AREA**

WHAT IS AN ILLICIT DISCHARGE?

The United States Environmental Protection Agency (EPA) defines an illicit discharge as "any discharge into a storm drain system that is not composed entirely of storm water." This means that any water containing household cleaning or yard care products, fertilizers, dog waste, car soaps and automotive fluids... IF deposited into the storm drain system...IS considered an illicit discharge.

Chesapeake Bay Pollution Reduction Plan

Londonderry Township was approved by the DEP to enter the next steps in restoration efforts on our local water bodies and the Chesapeake Bay. This comes in the form of the Chesapeake Bay Pollution Reduction Plan (CBPRP), a DEP mandated plan to meet the Total Maximum Daily Load (TMDL) requirements set by the federal government.

This plan sets a 5-year goal for States in the Chesapeake Watershed to reduce pollution in their local waterways by installing Best Management Practices (BMPs). The Township is required to reduce pollution caused by sediment by 10%, Phosphorus by 5%, and Nitrogen by 3%.

A midpoint assessment was done in July to observe the efforts of the federally mandated States. The Chesapeake Bay's overall watershed has made considerable progress, overall efforts exceeded the 60 percent goals for reducing phosphorus and sediment, but additional work is needed to meet the goal for nitrogen.

Pennsylvania's evaluation shows that we as a state are significantly behind in meeting our target reductions. We are off track on meeting our goals for agriculture and urban/suburban runoff. To meet our requirements, it will take a community effort so make sure you are doing your part so we can all "Save the Bay" together!

The following information is something you should read and make an emergency plan for yourself or your whole family. Since September 11, 2001 there has been an even bigger demand to be prepared in the event of an emergency and we all need to take a look at what we can do to help. In the past we depended on the local fire company to handle emergencies, but it is at a point where they can't do it alone. Creating the Emergency Management Agency was the first step, forming a team of volunteers was the second. Some members of the team have been involved with the fire company and/or the ambulance service for many years and we depend on their experience in emergencies. However, you don't have to have a background such as theirs to help. The EMA has regular meetings and training is provided throughout the year to those wanting to volunteer.

Our team of dedicated men and women look forward to welcoming you aboard, should you decide to become a volunteer. Please call Les Gilbert, Coordinator, 717-350-3492 or the Township Office, 944-1803 for more information on becoming a volunteer.

Make a plan for what you will do in an emergency:

Be prepared to access the situation, use common sense and whatever you have on hand to take care of yourself and your loved ones. Depending on your circumstances and the nature of the attack, the first important decision is deciding whether to stay or go. You should understand and plan for both possibilities. **Develop a Family Communications Plan:** Your family may not be together if disaster strikes, so plan how you will contact one another and review and review what you will do in different situations. Consider a plan where each family member calls, or e-mails, the same friend or relative in the event of an emergency. It may be easier to make a long-distance phone call than to call across town, so an out-of-state contact may be in a better position to communicate among separated family members. You may have trouble getting through, or the phone system may be down altogether, but be patient.

Staying Put: There are circumstances when staying put and creating a barrier between yourself and potentially contaminated air outside, a process known as "shelter-in-place", can be a matter of survival. Choose an interior room or one with as few windows and doors as possible. Consider precutting plastic sheeting to seal windows, doors and air vents. Each piece should be several inches larger than the space you want to cover so that you can duct tape it flat against the wall. Label each piece with the location of where it fits.

If you see large amounts of debris in the air, or if local authorities say the air is badly contaminated, you may want to "shelter-in-place". Quickly bring your family and pets inside, lock doors, and close windows, air vents and fireplace dampers. Immediately turn off air conditioning, forced air heating systems, exhaust fans and clothes dryers. Take your emergency supplies and go into the room you have designated.

Seal all windows, doors and vents. Watch TV, listen to the radio or check the Internet, if available, for instructions.

Getting Away: Plan in advance how you will assemble your family and anticipate where you will go. Choose several destinations in different directions so you have options in an emergency. If you have a car, keep at least a half tank of gas in it at all times. Become familiar with alternate routes as well as other means of transportation out of your area. If you do not have a car, plan how you will leave if you have to. Take your emergency supply kit and lock your door behind you.

At Work or School: Think about the places where your family spends time: school, work and other places you frequent. Talk to your children's school and your employer about emergency plans. Find out how they communicate with families during an emergency. A community working together during an emergency also makes sense. Talk to your neighbors about how you can work together.

Making a kit of emergency supplies:

Water: One gallon of water per person per day, for drinking and sanitation. Children, nursing mothers, and sick people may need more water. Keep at least a three-day supply of water per person.

Food: Store at least a three-day supply of nonperishable foods such as ready-to-eat canned meats, fruits, and vegetables. Also protein or fruit bars, dry cereal, peanut butter, crackers, nuts, canned juices, vitamins, etc. *First Aid Kit:* Items such as sterile dressings, cleaning agents, antibiotic ointment, adhesive bandages, eye wash, thermometer, prescription medicines, scissors, tweezers, petroleum jelly, antacid medication, aspirin, etc.



SECOND 4 YEAR CYCLE PUMPING AND INSPECTION SCHEDULE

The Township's OLSDS (On Lot Sewage Disposal System) pumping and reporting management program requires all properties in the municipality to be pumped and inspected on a regular 4-year interval according to the following district and pumping schedule.

DISTRICT Sewer District #1 & #2 Sewer District #3 On-Lot Management District B On-Lot Management District A

All properties have completed at least one pumping/ inspection and now the 4-year cycle has begun all over again. The required pumping/ inspection program for the District "1" and District "2" areas is currently underway effective June 1, 2018 and will run until June 30, 2019. Districts "1" and "2" lies roughly in the northwest portion of the Township and includes Miller Road, the north side of a portion of Round Top Road and the east side of the southern part of Schoolhouse Road and extends to along the north side of Foxianna Road. Please be reminded that if you have property located within Sewer District "1" and "2" you have until June 30, 2019 to comply with the pumping and inspection requirements. The OLSDS District Map and the registered pumper/hauler list is available thru the Township website or at the Township office if needed. Please keep in mind that only registered pumper/haulers as authorized by the Township are allowed to perform this required inspection.

KNOW BEFORE YOU PUMP

It is the responsibility of the property owner to know which District their property is located within and to have their septic systems pumped in the correct pumping cycle. However, if you or your pumper/hauler company have any questions about this program or to determine/verify which district and which 4-year cycle your property is located within, please call the Township office at 717-944-1803.

Per the OLSDS Ordinance, it is the responsibility of the pumper/hauler to forward a copy of the pumper/hauler report and the \$25.00 registration fee to the Township within fifteen (15) days of pumping.

Failure to comply with the reporting requirements of this program will result in fines being levied against the property owners that have not provided the required information.

ORDINANCE UPDATES

The Township is continuing to review and possibly update its Ordinances to address regulations that have become outdated or those which continue to generate concerns or complaints from citizens. Notices of public hearings for the review and adoption of any such Ordinance updates and revisions will continue to be listed in upcoming meeting agendas and on the Township's web page.

ZONING REGULATIONS AND PERMITTED USES

Township residents are encouraged to contact the Township Zoning/Code Officer for clarification as to what is a "byright" permitted use and what may or may not be a permitted primary or accessory use within any specific area of the Township before undertaking any construction project or presumed allowable activity. Many different permitted uses also require other site requirements or building improvements to be in place before the permitted use can be carried out. Just because the property may lie within a Commercial Zone or an Agricultural Zone does not guarantee the right of a property owner to operate a business or maintain farm-related activities without first having certain other conditions, improvements and/ or approvals in place. It should not be presumed that because your property is zoned commercial that you can operate a commercial business from your home any more than if your home lies in the agricultural zone that you can keep farm animals in your back yard. There are finite differences in the permitted "by right" uses and the uses permitted as accessory to the principle use of the building or property which must be investigated and addressed before undertaking certain activities. The Township staff is here to help and will do our best to answer any questions you may have regarding permitted uses within the Township.

PETS

STRAYS—Dogs & Cats—must be first be brought to the Township to receive voucher, then taken immediately to the Humane Society at 7790 Grayson Road in Harrisburg.

DOG LICENSES—applications are NOT available at the Township office. Residents may purchase a license online at **PADogLicense.com.** A metal tag will be mailed within a few days. Dogs over three months must be licensed by state law. If not, fines are up to \$300 for each violation. Fees collected are used to underwrite costs of monitoring PA kennels and puppy mills as well as other dog welfare initiatives not funded by tax dollars. **Dog tags run with the calendar year and must be renewed annually!**

SMOKE ALARMS

Get in the habit of changing the batteries in your smoke detectors and carbon monoxide detectors every fall and spring when changing the clocks for Daylight Savings Time.

SPACE HEATER TIPS

- Make sure that any space heaters are surrounded by at least three feet of empty space.
- Never place clothing or any other objects on a space heater to dry.
- Do not place space heaters near furniture or drapery.
- ✓ Turn space heaters off when you leave the house or go to bed.
- Avoid storing any combustible items
 near heaters.

FIREPLACE TIPS

- Get your chimney inspected each year to make sure that it is safe.
- Hire a chimney sweep to clean out your chimney every fall.
- ✓ Repair any cracks in fireplaces.
- Use fireplace screens to keep sparks and fire debris inside the fireplace.
- Do not ever use gasoline to start a fire in the fireplace.
- ✓ Never leave a fire unattended.
- Make sure that combustible materials are not stored within three feet of your fireplace.
- ✓ For natural gas fireplaces, get all connections and lines inspected before use each season.
- Remember that outdoor fireplaces can be just as dangerous as indoor units, and observe all safety precautions when using them.

HOLIDAY TIPS

- Do not use candles in Halloween jack-olanterns. Flashlights are much safer.
- Make sure that children's costumes are made with fire retardant materials.
- ✓ Use only fire retardant holiday decorations.
- Verify that all holiday lights and extension cords have been tested by an organization such as Factory Mutual or Underwriters Laboratory.
