**Detweiler Storm Water Update:** Mr. Letavic asked Mr. Foreman to update the BOS on the status of the information gathering for this project. Another dye test will be performed before back-filling. Edward Kenworthy provided the estimate to re-survey the area. BOS directed Mr. Letavic to 1st deal with the septic problem, then deal with correcting the easement problem and lastly the discharge of the pipe into the swale.  
  
**Colebrook Road Storm Water Project:** Mr. Letavic updated the BOS on this project, reviewing a meeting held on site with John Kessler, Darrel Becker and Doug Lamb to review punch list items from last fall, including erosion and curbing to ensure that water gets into the catch basins and not around them.
