Approval of Minutes – January 3, 2012

Mr. Geyer motioned to approve the minutes with a correction on page 2 removing the Fire Police Officer appointment which was placed in the minutes in error, Mr. Shellenhamer seconded. Motion approved.

Manager's Report – Steve Letavic

Fire Police Approval

Mr. Shellenhamer motioned to appoint William Slabonik as a Fire Police Officer, Mr. Geyer seconded. Motion approved.

Project Update

Mr. Letavic had asked Mr. Kenworthy to put a report together including an update on the bridge projects and the 537 Plan. The report was given to each of the Supervisors and he asked that upon their review they contact him with any questions.

Workflow Calendar

Mr. Letavic is working with department heads on implementing the major projects that were presented in the budget to be put into the workflow calendar for the year. Once the budget plan is married to the workflow calendar it will be distributed showing what's been budgeted, what will be done and when it will be done.

Code/Zoning Officers Report – Darrin Robinson

Inspection Districts

Mr. Robinson informed the board that he has divided the township into four districts and each week he will travel thru a different district. This will allow him to become familiar with the municipality, implementation of the MS4 and also assess code violations.

Plan Storage

Mr. Robinson informed the board of the newly installed storage units located in the Municipal Office that will provide storage and organization of construction plans.

OLSDS (On-Lot Sewage Disposal System)

Mr. Robinson stated that he and Steve Letavic will be meeting next week with Yvonne Bekelja, Swatara Twp. OLSDS Administrator, to review how they have implemented and administered the program.

Mr. Letavic informed the board that he believes Londonderry Township will have to implement the program by January 2013 and so they are beginning to research what surrounding municipalities are doing to be able to best implement it in our municipality. He stated that we want to meet the intent of the law without going beyond.

Safety Committee

Mr. Robinson informed the board that he has spoken with Penn Safe to set up training for the committee members, goals for 2012 have been set and he is looking for funding to purchase an AED for the golf course as well as the municipal building.

Engineers Report – Andrew Kenworthy

Round Top Road

Notice to proceed was given to the contractor effective January 5 and they are currently working on the project.

Foxianna Road

Design work is essentially complete, GP-11 application was submitted, anticipate having completed plans and project manual by January 31 and to start the project in April.

On-Lot Ordinance

HRG will schedule a meeting with the township to review and discuss the draft ordinance and develop a schedule for implementation to include in the ordinance. Preliminary schedule has this ordinance being implemented.

ACT 537 Plan

DEP has approved the report and associated plan preparation cost estimate. A Draft Act 537 Plan Update is scheduled to be to the Board of Supervisors by June.

Emergency Generator Containment

Design is complete, final plan detailing being completed, final plans to be delivered to Township by February 15.
